Sealed proposals for the water quality project described herein will be received at the office of the Knox County Soil and Water District (SWCD), Galesburg, IL until 8:00 A.M on October 31, 2025, and publicly opened at that time.

The proposed project is officially known as "IL Batch and Build Pilot in Knox County 2025" and consists of the installation of eight bioreactors in Knox and Warren County, Illinois. The purpose of this project is to improve water quality by reducing nutrient loss from tile drainage. The estimated cost range for this project is \$237,000-\$299,250. Work will be done at the edges of cropped fields adjacent to a creek. In general, the work involves, and is not limited to excavation, earthwork, grading, stabilization, and seeding. All sites are located within the 100-year floodplain, and any overhaul must be taken and disposed of in areas outside the 100-year floodplain.

This project is funded by the Illinois Department of Agriculture, The Nature Conservancy, and other sources, and requires that their rules and regulations are adhered to.

A pre-bid conference (hybrid) is scheduled for Thursday, October 16, 2025, at 1:00 PM via Zoom. Participation is not mandatory. Please contact Knox County SWCD to receive the webinar link.

Prevailing wage must be paid to all involved with the project. The contractor shall not pay less than the prevailing rates of wages to all laborers, workmen, truck drivers and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).

The contractor and all subcontractors associated with the project will be required to submit all certified payroll sheets to the Knox County SWCD no later than the 15th of the month.

The Plans and Construction Specifications governing the construction of the proposed conservation practices have been prepared by ISG and stamped by a Professional Engineer. These plans and the bid packet will be posted to the Knox County SWCD website (https://knoxcountyilswcd.wixsite.com/knox), and hard copies may be obtained at the Knox County SWCD office between 8:00 a.m. and 3:00 p.m. Monday through Friday. Proposals must be submitted on the form provided in the bid packet. Bids should be submitted for the batched construction of eight bioreactors. Bidders should consult the technical plans and specifications to develop bids based on the items of work required for each project site.

Project work may be started on December 1, 2025, and shall be completed no later than May 31, 2026. If this timeline cannot be met, Contractor shall give notice to the Knox County SWCD immediately after occurrence of an event that causes an excusable delay. Performance and payment bonds for 100% of the contract price will be required of the accepted bidder at time of signing contract.

Prospective bidders shall be skilled in the type of work called for in this Project and shall demonstrate the same through the submission of a resume listing all pertinent projects performed and the equipment used within the last five (5) years. At project completion all disturbed areas along the staging areas shall be free of material and debris, leveled and ready to be prepared for seeding. Any overhaul must be taken and disposed of in areas outside the 100-year floodplain. The contractor must contact JULIE to have the location of any utilities marked.
